GetResponse "Autofunnel prelaunch" Campaign Terms and Conditions

I. General Provisions

- 1. These Terms and Conditions govern the "**Autofunnel prelaunch**" Campaign ("Campaign").

- 3. Participating constitutes your acceptance of the Terms and Conditions hereof.

II. Taking part

- 4. Giving us your personal data is voluntary, but you will need to do it if you want to take part in the Campaign.
- 5. We'll process your personal data in accordance with the rules listed in these terms and conditions and all applicable law regulations. We take all reasonable steps to protect your personal data from loss, misuse, unauthorized use, access, inadvertent disclosure, alteration, or destruction.
